Consignor Agrees to the Following:

1. As a consignor I am entitled to one consignor pass to come to the Pre-Sale. If I volunteer and work at the sale, I am entitled to one worker pass to come to the Pre-Sale. If I am both a consignor **and** a worker, I am entitled to one of each of the passes. I may share/give my consignor pass to a friend but I may **not** share/give my worker pass to anyone else.
2. All items must be clean (no stains, holes, etc.) and functioning (no missing pieces and with working batteries included if applicable).
3. Pa Kids Market reserves the right to reject any item, and may also remove an item from the sale floor at any time.
4. Consignor is responsible for tagging, and pricing their own items.
  - If indicated on the tag, item will be discounted 50% off during the ½ price sale.
  - If no price is indicated on the tag, then a price will be determined by Pa Kids Market or the item will be removed from the sale floor.
  - Items must be a minimum of \$1
5. Consignor accepts responsibility to pick-up any unsold merchandise the Saturday of the sale, between 4:15 - 4:45 p.m.
6. Pa Kids Market is not responsible for any losses as a result of fire, flood, theft, damage, or lost or stolen items.
7. All sales are final and no returns, refunds, or credits will be given.
8. Consignor agrees to waive any and all claims for bodily injury, personal injury or any other loss resulting from participation in the sale, for whatever cause, against Pa Kids Market, Linglestown Life Church, any volunteer or participant in the sale.
9. Consignor understands that proceeds will be 70% of selling prices or higher based on the consignor incentive policy posted on the website ([www.pakidsmarket.com](http://www.pakidsmarket.com)) at the time of the sale.
10. All checks will be mailed within 10 days of the close of the sale. If the consignor has not received her/his check within 10 days it is her/his responsibility to contact PA Kids Market at [pakidsmarket@comcast.net](mailto:pakidsmarket@comcast.net). ALL EARNINGS CHECKS MAILED TO THE CONSIGNOR MUST BE CASHED WITHIN 30 DAYS OF THE CHECK DATE OR THE CHECK WILL BE CANCELLED AND THE FUNDS FORFIETED.
11. A \$7.00 registration fee will be assessed and collected from each consignor's check at the end of the sale.
12. **It is the Consignors responsibility to ensure all merchandise meets the U.S. Consumer Product Safety Commission's Recall criteria.**
